Trump hits Harris over Afghan ‘humiliation’

Former President Donald J. Trump attacked the Biden administration over its withdrawal from Afghanistan while observing the third anniversary of a deadly suicide bombing in Kabul, the Afghan capital, by visited Arlington National Cemetery. Later, the Republican presidential nominee addressed a gathering of National Guard members in Detroit.

Trump blamed President Biden and Vice-President Kamala Harris for the bombing and America's chaotic withdrawal from Afghanistan, which he argued led to the conflicts in Gaza and Ukraine. "Caused by Kamala Harris, Joe Biden, the humiliation in Afghanistan set off the collapse of American credibility and respect all around the world," Trump said. He added, "It gave us Russia going into Ukraine. It gave us the October 7, 2023 attack on Israel, because it gave us lack of respect."

Trump and his allies have pointed frequently to the suicide bombing at Abbey Gate at the Kabul airport on August 26, 2021, which killed 13 American service members and as many as 170 civilians, arguing that the Biden administration's handling of the event showed a disregard for American service members. During his speech in Detroit, Trump noted that he was criticizing "not that we withdrew, but the way we did it".

He repeated his promise to demand the resignations of senior military officials involved in the withdrawal. He also repeated his insistence that he could bring the wars in Ukraine and Gaza to an end immediately after being elected, though he has yet to offer specific plans for doing so. Still, Trump has been fending off criticism from Democrats and some veterans groups that he has been insufficiently respectful of the military. During their national convention, Democrats repeatedly brought up the claim that Trump, while President, called veterans "suckers" and "losers". This month, Trump drew the ire of

veterans groups after he described the Presidential Medal of Freedom, which honors civilians, as being "much better" than the Medal of Honor, the nation's highest military honor, because service members who receive it are often severely wounded or dead.

The Biden administration has noted that Trump made a deal with the Taliban in 2020 that set a timeline for America's exit. Democrats have argued that Trump flopped on the withdrawal after Biden saw it through. In a statement on Monday, Harris

mourned the loss of the 13 American soldiers killed in the airport attack and said she honored those who served in the 20-year war in Afghanistan. She also reiterated her support for Biden's "courageous and right decision" to withdraw troops from Afghanistan.

Ammar Moussa, a spokesman for the Harris campaign, attacked Mr. Trump's leadership. "The Biden-Harris administration inherited a mess from Donald Trump," he said in a statement. "Trump wants America to forget that he had four years to get out of Afghan-

istan, but failed to do it." Trump insisted that Democrats were "waging war" on the "rights and liberties" that the military was deployed to defend.

Govt pushed Meta to censor content: CEO

Meta Chief Executive Officer Mark Zuckerberg, in a letter to the House Judiciary Committee has alleged that the Biden-Harris administration "repeatedly pressurised" Meta's teams to censor posts related to Covid.

"In 2021, senior officials from the Biden Administration, including the White House, repeatedly pressured our teams for months to censor certain COVID-19 content, including humor and satire, and expressed a lot of frustration with our teams when we didn't agree. Ultimately, it was our decision whether or not to take content down, and we own our decisions, including COVID-19-related changes we made to our enforcement in the wake of this pressure," Zuckerberg said in the letter.

"I believe the government pressure was wrong, and I regret that we were not more outspoken about it," added the Meta CEO.

The status of an anticipated debate between US presidential candidates Donald Trump and Vice-President Kamala Harris is up in the air as the two campaigns squabble over

details. Donald Trump suggested Monday that he might back out of the scheduled ABC News debate with Harris on September 10 because, he said, the network is hostile toward Republicans. Trump said he wants to have a "fair debate" and welcomes "tough questions."

ABC "really should be shut out," he continued. "I'd much rather do it on NBC. I'd much rather do it on CBS. Frankly, I think CBS is very unfair, but the best of the group, and certainly I do it on Fox, I'd even do it on CNN. I thought CNN treated us very fairly the last time." On Monday, the Harris campaign said the dispute centres over whether microphones will be muted while the other candidate is speaking, a feature meant to decrease interruptions and employed during an earlier debate between former President Trump and then-candidate and current President Joe Biden.

मप्र के 15 हजार अतिथि शिक्षक बेरोजगार

10 साल की सेवा को कोई महत्व नहीं

भोपाल,(निप्र)। मध्य प्रदेश के सरकारी स्कूलों में शिक्षकों की कमी पूरी करने के लिए अतिथि शिक्षकों की हर साल भर्ती की जाती है। हजारों शिक्षक पिछले 10 से 15 साल से सरकारी स्कूलों में अपनी सेवाएं दे रहे हैं। इस वर्ष डीपीआई के एक आदेश ने करीब 15000 अतिथि शिक्षकों को बेरोजगार कर दिया है। दरअसल शिक्षा विभाग ने इस वर्ष अतिथि शिक्षकों की भर्ती में 30 फीसदी से कम रिजल्ट लाने वाले अतिथि शिक्षकों को दोबारा नौकरी पर नहीं रखने का आदेश जारी किया है। गौरतलब है कि इस समय प्रदेश के स्कूलों में अतिथि शिक्षकों की भर्ती की जा रही है।

दूसरों की गलती से हो गए बेरोजगार- खास बात यह है कि डीपीआई के इस आदेश से कई ऐसे शिक्षक भी बेरोजगार हो रहे हैं जिसमें उनकी गलती नहीं है। दरअसल कई बार सरकारी स्कूलों में अतिथि शिक्षकों से
